#### Introduction

This Privacy Policy describes how Longevity Labs (the "Company", "we", "us") collects and uses personal information about you.

This Privacy Policy describes the choices available to you regarding our use of your personal information and how you can access and update this information.

By using the Company's products, site, or other services, you agree to the collection, use, and disclosure of your information as described in this Privacy Policy. If you do not, please do not use the Company's products, site, or services.

The provision of personal data is a requirement necessary for the contract between you and the Company and to enable us to deliver our services effectively. If you choose not to provide your personal data, we may be unable to offer you our services in whole or in part. By not sharing your personal data, you acknowledge and agree that your access to some or all of our services may be limited.

**European Union (EU) Residents:** Those living in the EU should also view the "Information Collected from Individuals in the European Union" section of this Privacy Policy to learn additional information about how we collect and use your personal information in compliance with EU data protection laws.

#### **Information We Collect**

For the purposes of this Privacy Policy, personal information means information that either identifies, relates to, is capable of being associated with, or could reasonably be linked, directly or indirectly, with you or your household.

Categories of information collected

- **Payment information,** including your billing address and method of payment (e.g., bank details and credit, debit, or other payment card information).
- Transaction information, including information about your purchase of our product.
- **Data concerning health**, specifically any health information that you choose to share with us.
- Technical and usage information, including your internet protocol (IP) address, mobile
  advertising ID, geolocation information, web browser type and version, and information
  about how you use our site (including information gathered through cookies and other
  similar technologies).
- Marketing and communications information, such as your preferences in receiving marketing, promotions, and sales offers from us.
- Other information you provide to us, including the content of your communications with
  us, and information you post or disclose on our site, on message boards, in chat rooms, or
  in other public areas.

You should be aware that any information you post or disclose in public areas on our site may be read, collected, and used by others who access them. The definition may vary in different jurisdictions, and for the purposes of this Privacy Policy the broadest meaning applies.

#### Information We Use

We use your personal information for our legitimate business purposes, which include:

- Communicating with you. ## **Processing of Personal Data for Enhance Your Search**

## **Children's Privacy**

# **Use of Distributed Ledger Technologies**

The Company may employ distributed ledger technology (DLT), including blockchain, as a part of its service offerings. You may access our services using your blockchain wallet address, which serves as a unique identifier within the blockchain network.

The blockchain is a decentralized, append-only ledger that chronologically records transactions in a secure, transparent, and immutable manner. Each transaction on the blockchain is recorded in a "block," linked to previous transactions using cryptographic hashing, forming a continuous chain.

Given the immutable and transparent nature of the blockchain, once data is recorded, it cannot be altered or erased. This includes data that could potentially be considered personal information under various data protection laws.

The use of cryptographic hashing and the decentralized nature of blockchain significantly enhance the security and privacy of data, albeit making personal data embedded in the blockchain visible to other network participants. Data transmitted to the blockchain, such as public keys and transaction data, may include elements that qualify as personal data under data protection regulations. This may also apply to personal data that has been encrypted or hashed.

By using our services and agreeing to this Privacy Policy, you acknowledge that any personal data transferred to the blockchain may be considered as data made publicly available by you. Due to the inherent characteristics of blockchain technology, it may be challenging to exercise rights such as data modification or erasure as typically afforded under data protection laws.

You acknowledge that you are aware of the functionalities and risks associated with DLT and blockchain. You are responsible for safeguarding your blockchain wallet and understanding the privacy implications of data published on a blockchain.

If you are not comfortable with the irreversible nature of blockchain data or if your personal data requirements are inconsistent with the characteristics of blockchain technology, we recommend not using our services where blockchain technology is employed.

Legal basis for use of personal information
